Irish Construction Industry Partners Working For A Safer and Healthier Workplace

THE AWARD

The CSPAC/CWHT Award will be awarded to an organisation / individual who has introduced an innovation / change to the way that they operate that has made improvements to health outcomes in the workplace within the last three years. This may have been an engineering change or indeed a management change that has been adopted to address a problem that existed. The aim of this award is to highlight and reward the commitment to improving health awareness performance or improve health in the construction sector.

HOW TO APPLY FOR THE AWARD?

Candidates may nominate themselves or indeed they may be nominated by a client, main contractor or worker – anyone who is of the opinion that the proposer has grasped a health issue and introduced a novel / innovative / change to address a problem or highlighted awareness. The action taken should have been instigated in the last three years and should have been introduced specifically related to health.

WHO IS ELIGIBLE?

Any organisation / individual working in the construction industry in Ireland.
